JREC will be voluntarily fully complying with Public Service Commission Emergency Order #11. Until this State of Emergency has been lifted, we will not be disconnecting any member's service. I encourage our members who have run into hard times to please contact our office and work out a payment arrangement to avoid any disruption in service once the order has been lifted.

The JREC Board of Directors has also postponed our annual meeting tentatively to July 25. This measure is aimed at protecting you, our member. By not holding a meeting during the outbreak of a contagious disease we



hope to minimize exposure and reduce the transmission of infection. Our concern is for the safety of you, our member, and our employees who keep the lights on. Be sure to keep your April issue of this magazine as this will be the only annual report you will receive.

All absentee ballots will remain unopened and in a secure location until the annual meeting is held. Your vote will still count!

Please follow all recommendations from the Centers for Disease Control and help protect yourself and others in our communities. We will get through this crisis together.

NAVIGATING UNCERTAINTY

Jump River Electric Cooperative offers links to resources to help business owners.

Small businesses are at the heart of local communities. During the current situation of extended economic uncertainty, there are numerous state and federal resources available to help businesses. Visit www.jrec.com or www.EconDev.DairylandPower.com to access links and more information on these programs.

Given the high level of need, applications should be submitted as soon as possible. The U.S. Senate Committee on Small Business & Entrepreneurship released a guide to help businesses learn more about the Coronavirus Aid, Relief, and Economic Security (CARES) Act. It offers guidance on the following topics:

- Paycheck Protection Program to cover the cost of retaining employees
- Emergency Economic Injury Loans & Grants to offer immediate assistance to small businesses
- Small Business Debt Relief Program to help business owners navigate the challenge to keep up with payments on current Small Business Administration (SBA) loans
- **Resources** to access free counseling services

The Wisconsin Economic Development Corporation (WEDC) is also offering a Small Business 20/20 Program for current community development financial institution (CDFI) clients. Businesses that are not CDFI clients can work with the WEDC to access funding through other programs as resources become available.

Local financial institutions, local small business development centers, local economic development organizations may be able to help businesses navigate the application process on some of the above-listed loan and grant programs.

The Community Cents program is an amazing way our members can give and know that the causes it supports will be receiving 100 percent of their donations. How do you give? You can sign-up by completing the form at left. Energy bills that follow your sign-up will be "rounded-up" to the next highest dollar. For example, an energy bill for \$92.73 would be rounded up to \$93.00, with the additional 27 cents going to the Community Cents program.

Small change indeed, but multiplied by 8,500 members, it is small change that changes lives. On average, this program will cost a member around \$6 a year with the maximum being \$11.88 a year.

Just as the citizens who joined together so long ago to bring power to rural Wisconsin when private power companies refused, Community Cents helps members ban together to support worthy causes in our community.

The Community Cents board is made up of some of the most diligent, caring ladies I have ever met, and members can be assured that they will make thoughtful decisions when allocating the donated funds. The committee members are pictured below.

PREPARE A BACKUP PLAN IF YOUR HEALTH RELIES ON ELECTRICITY

Jump River Electric Cooperative (JREC) is committed to providing you with safe and reliable energy, but it's impossible for us to guarantee uninterrupted power. Outages caused by severe storms, vehicle accidents, tree limbs, animals, equipment failure, or other problems could leave you without power for hours or, in very rare cases, days.

That is why it is important if you or someone in your household depends on any life-support equipment to have an emergency backup plan. It is also important that JREC is aware of your need for life-support equipment.

Before an emergency arises, JREC suggests the following:

- Obtain a backup source of power recommended by the manufacturer of any critical care equipment you have in your home. For example, battery backups, portable battery pack, or portable generators can provide you with the electricity you need until power can be restored.
- Keep a full charge on battery-operated devices or have extra batteries on hand and check these batteries periodically. Unused rechargeable batteries may need charging.
- Keep your cell phones charged so you can call for help and family and friends can check on you. Be sure this cell number is also listed as your primary contact number with JREC.
- Have a plan. Talk to relatives or friends about places you can go in the event of a long-term outage.

JREC makes every effort to give priority in restoring service to members on life-support systems. If you or a family member depends on life-support equipment, please fill out the form below and mail it to us as quickly as possible. You can also call us at 715-532-5524 to provide us with this information. Please be sure you continue to update us when and if your life-support equipment changes or if back-ups or generators are added to your location.
